- 2017 **Evaluator of Ethical Code of Conduct.** I assessed the ethical code of conduct of ASM Pavia (with Ceva E. & Bocchiola M.), by identifying its shortcoming and highlighting potential paths for improvement. Theoretically, I referred to the state-of-the-art literature in business ethics, and practically I compared ASM Pavia's ethical code with those adopted by similar public companies.
